## **\*\$1000.00 Armenian Genocide Scholarship Question Spring 2018**

The **Armenian Genocide of 1915-1923** is an historical fact. Facts can be verified with evidence while opinions cannot. For more than a century the Turkish government has denied that the Armenian Genocide occurred. As you conduct your research you will find that there is an array of information readily available that addresses the facts, opinions and biases regarding the Armenian Genocide. In order to draw informed conclusions about the accuracy and validity of the events that took place leading up to and during the Armenian Genocide, a critical examination of the available information is needed.

Henry Morgenthau, United States Ambassador to the Ottoman Empire (present day Turkey) from 1913-1916, referred to the Armenian Genocide in his memoir as follows:

*I am confident that the whole history of the human race contains no such horrible episode as this. The great massacres and persecutions of the past seem almost insignificant when compared with the sufferings of the Armenian race in 1915. He also stated: When the Turkish authorities gave the orders for these deportations, they were merely giving the death warrant to a whole race; they understood this well, and, in their conversations with me, they made no particular attempt to conceal the fact.*

***The core purpose of your essay is to answer this question: How do we know the Armenian Genocide really happened?*** A variety of historical thinking skills should be demonstrated in the essay that reflect your ability to analyze, compare, and contrast multiple texts for content, intent, impact, and effectiveness. You are also expected to examine primary and secondary sources that are related to the Armenian Genocide but are from different perspectives. By using these historical thinking skills, you will be able to distinguish between reliable and unreliable sources in your research. Questions you might ask yourself about the sources uncovered in your research are: Why does this information even exist? How do I know if this information is reliable and truthful? How do I know if the historical content is accurate? In selecting the sources for my conclusions, did I carefully evaluate the authors' credentials?

## **A Few Words Concerning Organization**

Think of your opening and closing paragraphs as "bookends" that hold the body of your essay in place. Within the body of your paper, be certain that you support your statements with information derived from credible sources. Your concluding paragraph should summarize the key points while making clear your opinion on the topic. Those evaluating your essay will be very interested in your voice (your personal opinion and feelings) in addition to having demonstrated clear knowledge of this period in history.

### **Preparing Your Essay for Submission**

**VERY IMPORTANT:** Save your document using the following format: last name first initial\_AG2018; example for Joan Smith essay would be saved as: **smithj\_AG2018**.

#### **Format: (MLA format):**

- ◆ Essays must be typed double spaced using Times New Roman 12 font; handwritten essays are not accepted.
- ◆ Body of essay should not exceed four typed written pages; not included in the page count is a required Works Cited page and cover page.
- ◆ Please include parenthetical citations.
- ◆ Include your name on the top right corner of each page.

#### **Cover Page must include:**

- ◆ Title of essay
- ◆ Student's name
- ◆ Student's email and grade level
- ◆ High school name, address and phone number
- ◆ Name of school counselor and direct phone number or extension

#### **Mail and electronically submit your essay:**

**Both an emailed version and two mailed hard copies are required by the April 9, 2018 deadline. *Please paperclip (do not staple) the hard copies and mail them unfolded in a manila envelope.*** Use the correct postage amount or your essay will be returned unopened. Please email your essay as a Microsoft Word document to:
